

In the time I have been here, I have focused on getting to know the library and the community it serves. Mock Trial Volunteers

The NPBA is again looking for volunteer attorneys to assist in the 16th Annual Model Judiciary Program for the Norfolk Public Schools. The program was started in 2004 and, after a three-year absence due to the pandemic, is back. In the program, students are taught basic trial skills and final mock trials conducted in Norfolk Circuit Court.

In the past, the program has been a great success due to the enthusiasm and hard work of the students and participating attorneys and, through the years, has served all Norfolk Public middle schools. We are also fortunate to be supported by members of the bench and the Norfolk Police Department. The middle schools participating this year are Ghent School, Northside, Lake Taylor School, Academy for Discovery, Crossroads School, Ruffner, Rosemont and Blair.

It is scheduled to be an eight-to-ten-week program starting in February 2023. Students will receive instruction one day a week for approximately an hour to an hour and a half after school between 3:00 and 4:30 p.m. The trials matching one school's team against another's are scheduled for a yet-to-be-determined date in mid to late April in Norfolk Circuit Court. At the conclusion of those trials, the two top teams are chosen to participate in a trial a week later to determine the top middle school team in the program. At least 20-25 attorneys are needed so that a minimum of 2-3 attorneys can be assigned to each school. With that many attorneys at each school, the commitment can be minimal, one to two hours a week every other week if needed. Previous volunteers have commented on how well the students have done and on their enjoyment of watching the students' growth throughout the process. The experience of working with the children is very rewarding as they are so appreciative of being able to work with real attorneys.

Notice for Reappointment of United States Magistrate Judge Robert J. Krask

The current term of office of United States Magistrate Judge Robert J. Krask at Norfolk and Newport News, Virginia, is due to expire on September 1, 2023. The United States District Court, as required by law, has established a Merit Selection Panel composed of lawyers and citizens to consider the reappointment of the magistrate judge to a new eight-year term.

The duties of a magistrate judge include the following: (1) conduct of most preliminary proceedings in criminal cases; (2) trial and disposition of misdemeanor cases; (3) conduct of various pretrial matters and evidentiary proceedings on delegation from the district judges of the district court; and (4) trial and disposition of civil actions upon consent of the litigants.

Comments from members of the bar and the public are invited as to whether the Merit Selection Panel should recommend that the incumbent magistrate judge be reappointed. Any comments should be directed to:
