## President's Message

We've reached the holiday season and are rounding out 2023, with the associated business and family gatherings adding yet more events into our packed schedules. Practicing law is a time-consuming endeavor at any level and, for those of us who own/run a law firm or even those that manage other attorneys/staff, the work seems endless. Since starting our firm in 2012 I have spent a great deal of time learning as much as I can about how to manage all the tasks that need addressing – how to be a better leader and be more efficient to allow the time to devote to my firm and, importantly, my life outside of work.

A lot of attention has been spent on mental wellness in our profession and for good reason. I strongly feel that for all the good work that is being done to treat the effects of the pressures of the practice of law, a more effective approach is to address the root causes themselves. I've been fortunate to be part of many groups of fellow law firm owners and exposed to thought leaders across different industries who have found ways to successfully manage these stressors.

In the remaining President's Messages of my term, I will share the top things I've found most impactful in addressing these concerns we all face with the hope that they may be of similar value to you. I'll start this month with a high-level concept and what I believe is the most important – purpose.

What I mean by "purpose" is determining what you want to accomplish. What are your goals? I spent the better part of my early career doing the work of a lawyer. I had cases, mostly assigned, and did whatever was needed for those cases. I never gave much thought to myself beyond wanting to do a good job, get paid well and perhaps advance in the law firm where I was employed. Looking back at my 25-year-old self entering the practice of law, I wish I had taken more time considering what I ultimately wanted to accomplish. Without a well-defined goal, how are you going to reach it? I believe that having a clear vision of what you want to achieve is of paramount importance. You can then plan steps to reach the goal. To paraphrase Lewis Carroll, "If you don't know where you're going, any road will take you there." I encourage you to think about what your ideal professional life looks like; everyone is unique and has a different definition of what being fulfilled means for them. Whatever it may be, identify it and then start working toward achieving it. I can share that, once I figured out my "why," which was running a law firm, the long hours became easier. I am more often energized than drained. So, as we head into 2024, find your "why."

In my next President's Message, I'll address my most important transformative practical tool – time management.

This is because when cases are appealed, all media needs to be transferred to the Supreme Court of Virginia Network, and inserting flash drives into Clerk's Office computers poses a security risk.
