## PRESIDENT'S MESSAGE

I think we can all agree that diversity is good. Most of our society, including members of the legal profession, have come to recognize the importance of acknowledging, accepting and, most importantly, embracing the differences among people with respect to such factors as age, race, class and gender. Our profession recognizes that diversity is especially crucial in today's global marketplace, as we interact with different clients and cultures. The advantages to diversity include increased creativity and productivity as individuals with different perspectives and skill sets work together toward a common goal.

While members of the legal profession may value diversity, the profession certainly does not parallel the diversity in our society. In 2010, the American Bar Association's Presidential Diversity Initiative issued its report and recommendations ("Report") concerning the state of diversity in the legal profession. While acknowledging progress, the Report concluded that "the lack of genuine diversity remains a disappointment" as, despite the efforts of bar associations, "thus far, racial and ethnic groups, sexual and gender minorities, and lawyers with disabilities continue to be vastly under-represented in the legal profession." The Report articulated four rationales for creating greater diversity in the legal profession.

- The Democratic Rationale: Lawyers and judges have a unique responsibility for sustaining a political system with broad participation by all its citizens. A diverse bar and bench create greater trust in the mechanisms of government and the rule of law.
- The Business Rationale: Business entities are rapidly responding to the needs of global customers, suppliers, and competitors by creating workforces from many different backgrounds, perspectives, skill sets, and tastes.
- The Leadership Rationale: Individuals with law degrees often possess the communication and interpersonal skills and the social networks to rise into civic leadership positions.
- The Demographic Rationale: Our country is becoming diverse in many dimensions and we expect that diversity to increase in coming years. The Census Bureau projects that by 2042 the United States will be a "majority minority" country.

Setting aside whether the legal profession "needs" to parallel society with regard to diversity, there is no escaping that the profession is becoming more diverse, which is reflected in the membership of the Norfolk Portsmouth Bar Association.

But with diversity comes the challenge for NPBA to meet the needs of a diverse membership. Based on Bureau of Labor statistics, our nation's workforce contains as many as four generations. NPBA membership reflects this reality, as the Association has student members in their early twenties, a number of active senior members in their eighties, and even a practicing attorney in

### (PRESIDENT'S MESSAGE CONTINUED)

his nineties. Diversity encompasses more than just age. More than 25% of NPBA members are women or minorities. And diversity extends to practice areas. While the majority of the membership practices with private firms, more than 10% work for the federal, state or local government or practice as in-house counsel. Of those members working for firms, 33% are employed by larger (25 attorneys or more) firms, 8% are employed by mid-size firms (10 to 24 attorneys), 44% are employed by small firms, and 15% are solo practitioners.

Consider for a moment the divergence of law practices with some attorneys with over 40 years in the profession with a large firm looking at retirement; others with 20 years as a solo practitioner, juggling a work schedule while caring for aging parents and school age children; others with five years of practice as in-house counsel, a spouse and perhaps an infant; and finally the new associate who is single, tech savvy and still trying to determine whether he or she has made the right career choice. How does a bar association meet the needs of each member? Do we go completely digital, leaving senior lawyers (who still have their secretaries print out email) to fend for themselves? Or do we ignore Facebook, LinkedIn and Twitter as passing fads and risk becoming largely irrelevant to a growing percent of the membership? And how does an association assist the sole practitioner with a single paralegal, the city attorney trying to meet the legal needs of the council, the in-house lawyer with a single client and the partner in a larger firm with a specialty practice? And how can a bar association help that lawyer who just passed the bar and "hangs out a shingle" in order to make a living? There are no easy answers to these questions. But there is too much to be gained by diversity in the NPBA to either ignore or forego any attempt to answer the questions, and try to meet the expectations of all members.

The NPBA recognizes the generational issues and diversity of practices which, when coupled with the changing technology, create an ongoing challenge to make the Association relevant to its members. While the NPBA newsletter still shows up in hard copy, it is available on line and the Association has established an ad hoc technology committee to consider the likes of Facebook, LinkedIn and Twitter as potential tools to serve its members. The NPBA strives to provide a menu of continuing legal education that will meet the needs of all of its members, including litigators and non-litigators, civil and criminal lawyers, and those practicing in General District Court as well as in Circuit Court. The Association's six standing committees are populated with an eye toward diversity so that the NPBA can consider all issues relevant to a particular committee from a number of different perspectives.

The NPBA has a wealth of diversity in its membership, but keep in mind that the only way the Association can take advantage of diversity is if the membership participates. To that end, become involved in the NPBA. Tell your leadership when the Association is meeting your needs and expectations. If you think the Association is missing the mark, tell your leadership why, and how to better serve you. After all, NPBA is only as effective as its participating members.

# 2012 NORFOLK PUBLIC SCHOOL MIDDLE SCHOOL MOCK TRIAL PROGRAM

For the seventh year, approximately thirty members of the NPBA taught basic trial skills to middle school students from the Norfolk Public School system. The mock trial program originally began with two schools and has now grown to seven schools with over 100 students participating. The seven middle schools that participated this year were Azalea Garden, Blair, Lake Taylor, Norview, Northside, Rosemont and Ruffner. The program began in early February and students met weekly with the volunteer lawyers who taught lessons on opening statement, direct examination, cross examination and closing statement. The students were assigned roles as attorneys and witnesses for the mock trial case, *State v. Karen Dennis*, a criminal case based on charges for destruction of property and hacking into a computer to change grades. Thanks to the continued support of the Norfolk Circuit Court, the program concluded with mock trials in six separate courtrooms on April 20, 2012 pitting a prosecution team from one school against a defense team from another. Judge Joseph A. Migliozi, Jr. of the Norfolk General District Court and local attorneys and NPBA members Kelly St. Clair, Dave Lannetti, Michael Rosenblum, Corrynn Peters and



Sherri Carr sat as judges for the trials. Following the trials, verdicts were rendered and judges provided valuable feedback to the students. Each of the middle school students who participated in the final trials received participation medals for their efforts.

The Mock Trial program is held annually from February to April and is run through the Public Relations Committee. This year's program was co-chaired by Wayne Williams and Cas Richardson who wish to thank all the great attorney volunteer teachers, Sandy Claxton of the Norfolk Circuit Court, Dorie Banks of the Norfolk Public Schools and the presiding

judges who all made the program possible and highly successful again this year.

### SUPREME COURT OF VIRGINIA

Effective July 1, 2012, the Justices of the Supreme Court of Virginia have determined that certain costs in cases filed by court-appointed counsel or cases filed pursuant to indigent status will not be reimbursed.

The costs affected by this decision are those incurred when using a vendor to print, copy, bind, and serve the following documents: Petition for Appeal, Brief in Opposition, Reply Brief (at the petition stage), Petition for Rehearing, Petition for a Writ of Habeas Corpus, Petition for a Writ of Mandamus, Petition for a Writ of Prohibition, Petition for a Writ of Actual Innocence, Motions.

This policy applies to the above referenced documents filed July 1, 2012 and thereafter. (Note: Rules 5:4, 5:6, 5:7, 5:7A, 5:7B, 5:17, 5:17A, 5:18, 5:19, and 5:20 do not require that such documents have a binding. Instead they are acceptable if stapled.)



### NORFOLK CIRCUIT COURT

Please mark your calendars and notify your staff.

Wednesday, November 21, 2012 – The court will be open until noon. The only criminal cases the Court will hear are guilty pleas, bond hearings, probation violations, and (with the consent of the judge) sentencings. The only civil cases the Court will hear are uncontested divorces, motions and concealed weapons permit appeals.

Monday, November 26, 2012 and Tuesday, January 22, 2013 – No jury trial except in assigned cases by order of the judge.

Friday, April 19, 2013 – No Docket – Regional Judges' Meeting.

Monday–Wednesday, May 13 – 15, 2013 – No Docket – Mandatory Judges' Conference.

Tuesday, June 11, 2013 – Primary Elections (assuming there is a primary) – the only criminal cases the Court will hear are guilty pleas and motions that will not require testimony of witnesses. The only civil cases the Court will hear are uncontested divorces in which the defendant has signed a waiver, appeals of the denial of concealed weapons permits, and motions that will not require the testimony of witnesses. If there is no primary, the Court will have a regular docket.

Friday, September 20, 2013 – No Docket – Regional Judges' Meeting.

Tuesday, November 5, 2013 – General Elections - the only criminal cases the Court will hear are guilty pleas and motions that will not require testimony of witnesses. The only civil cases the Court will hear are uncontested divorces in which the defendant has signed a waiver, appeals of the denial of concealed weapons permits, and motions that will not require the testimony of witnesses.

Thursday, December 12, 2013 – Last day of jury trials until Monday, January 6, 2014.

Thursday, April 18, 2013, and Thursday, September 19, 2013, will serve as sentencing dates.

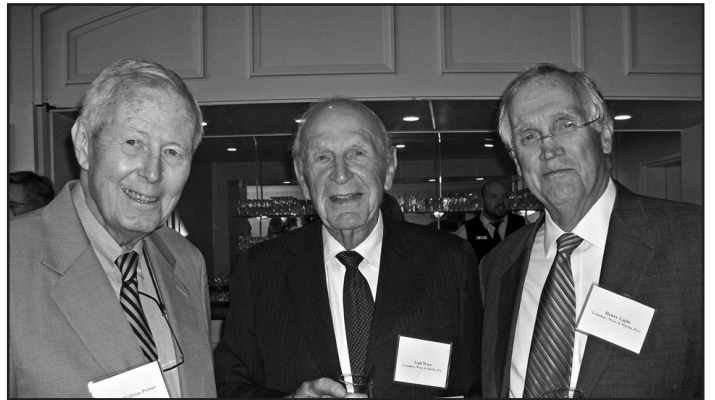

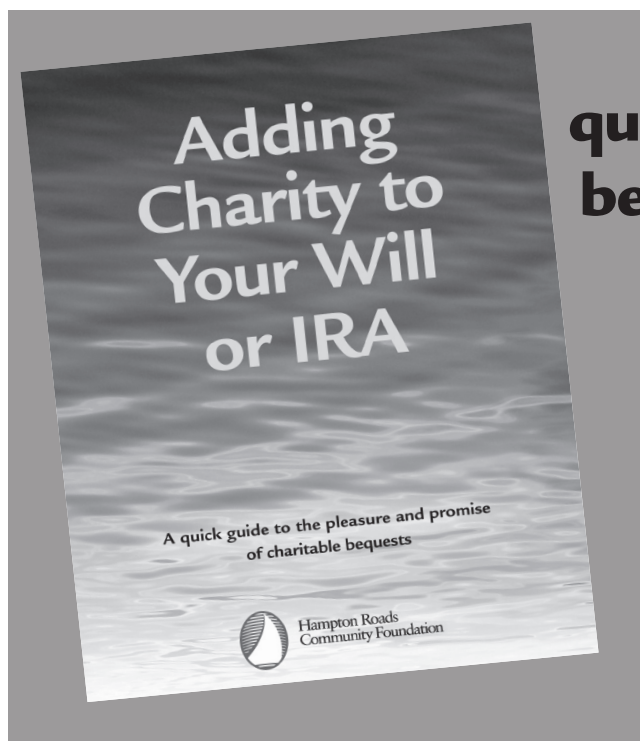
