noble profession has not waned. Upon reviewing a list of NPBA past presidents since 1907, I am honored beyond words to be following those past bar leaders. William P. Dickson, Jr., one of my mentors as a new practicing attorney in 1977, is among them (a memorable admonition by Coach Dickson, which I took to heart, was to never wear brown shoes with a dark suit on a business trip...times and fashion correctness, they do change). So is Guil Ware, who on occasion I have had the privilege to work with on over the years, and respect and admire so much. Other names, like Beryl Adler, appear to me to be the Who's Who in Norfolk community leadership. Indeed, I know of no other profession which has so many contributors toward the economic and social health of Tidewater.

Our profession is self-regulated. This is a privilege not to be overlooked or taken for granted, not a right. It is our duty to maintain the level of competency in our profession, first and foremost our own, to maintain the integrity of our profession, to promote the Rule of Law, and to serve the public by improving their access to justice and their understanding of civil and criminal process and court procedures. INTERVIEWS WITH THE BENCH: ADVICE AND INSIGHTS FROM LOCAL JUDGES

Featured Judge: The Honorable Tasha D. Scott, Judge, Norfolk General District Court



Judge Tasha D. Scott was appointed to the Norfolk General District Court bench in 2015. Prior to her appointment, she served as an Assistant City Attorney for the City of Norfolk for ten years. She graduated from the College of William & Mary and the George Washington University Law School. Among her various involvements, she presently serves as a faculty member for the Virginia State Bar Harry B. Carrico Professionalism Course, a member of the Board of Governors for the Criminal Law Section of the Virginia State Bar, and as an at-large board member of the Virginia Association of District Court Judges.

Q.: How did your time as a City Attorney prepare you for your role as a judge?

A.: Holding the position of a public servant is both a privilege and honor. The courts see people from many different walks of life. As a city attorney I was fortunate to have the opportunity to work with and learn from the public. A career in public service requires you to have a sense of purpose greater than yourself, any one person or entity, and appreciate that you can be an instrument of change or a pathway to equal access to justice. That was as true in the City Attorney's office as it is today.

THE INTERVIEW:

Q.: What makes you hopeful about the future of the practice of law?

A.: The level of advocacy and professionalism of the local bar, especially the newest members, inspires me. They are conscientious and astute, and offer fresh, creative perspectives. All of this is encouraging to me. With those qualities and people leading the way I have no doubt the future practice of law is bright and promising.

Q.: Do you have any pet peeves regarding attorney conduct in your courtroom?

A.: Never disregard the importance of civility. Just because you may disagree with an opposing party does not mean you have to be disagreeable in your behavior.

Q.: What three pieces of advice would you give to young attorneys?

- A.: 1. Never do or say anything to compromise your credibility or integrity.
 - 2. Don't take a job just for a job's sake. You will do your best and most rewarding work in a position that actually interests you.
 - 3. Keep balance in your life. Make sure you have something outside of work that promotes well being to maintain a healthy perspective.


