#### PRESIDENT'S MESSAGE



Robert V. Timms, Jr.

This message will arrive quite a while after the three judge panel from the 9th Circuit Court of Appeals heard oral arguments on the lower court's order temporarily restraining the President's executive order which, among other things, instituted a ninety (90) day visa suspension for people arriving to the United States from seven specific countries.

Like many of you, I listened to the oral arguments on the radio. I found it fascinating to actually hear oral arguments without being in the courtroom. I wish we could hear more arguments in real time. I think the American people would get a better sense of the appellate process rather than reading a filtered version of the proceedings through a reporter. The public would better see how aggressively the judges delve into the positions of each party. As I listened, it quickly brought back memories of my first year in law school and my participation in the moot court competition.

The two attorneys representing the State of Washington and the United States are well qualified attorneys, experienced in the art of appellate argument. During the course of the argument, the judges asked many pointed questions of each side. The attorneys' long pauses and attempts to respond or move the discussion to other issues caused me to have flashbacks (and not pleasant ones) to my own periods of utter silence as I, in a frozen state, astutely and succinctly scrambled to respond to the judges' questions. I only had my classmates listening to the proceeding, not an entire nation. I sympathized with the attorneys arguing their positions before the panel.

After listening to the oral arguments, I also realized that no matter how long we have been practicing law, we all face situations where we, for a while, feel like a first year law student or a newly admitted attorney. Since the arguments were conducted by telephone, I assume each lawyer had some other lawyers in the room, possibly handing them case law or notes with suggestions. During the long pauses, I could also imagine the lawyer looking up to get a consensus as to how best to respond.

The Young Lawyers Section of our association is beginning to institute a mentorship program. Listening to the oral arguments and imagining the other attorneys in the room providing assistance to the lead attorney reminded me that there are many times when we all need an experienced colleague to listen and to act as a sounding board. The Young Lawyers Section will be reaching out to us to connect younger members with experienced attorneys. Over the years, I have enjoyed talking to other lawyers about various matters that have run the gamut, including ways to handle particular legal issues, ways to develop a practice area or to structure a law firm and merge law practices, and just discussions of general business matters. I have enjoyed doing this because I like

#### PROTECT AND PRESERVE THE RULE OF LAW

One of the missions of the NPBA Foundation is to promote the Rule of Law. As NPBA President Timms discussed in his column in last month's edition of the *Bar Bulletin*, the NPBA Foundation is about more than awarding scholarships to deserving students. We are very interested in supporting projects that could serve to educate the public about the importance of the Rule of Law in our community.

The Rule of Law is the bedrock of the government that our founders established over 225 years ago and that we, as lawyers, are charged with acting as stewards of that government. The United States "had the great good fortune to be grounded in English traditions, especially the idea that the law, not the state, is supreme." Luckily, we haven't really had to think about this core principle of American government very often – which is a good thing. But now, all of the members of our Association should take a few minutes to think about what the Rule of Law means, and what we might have to do to protect and preserve this vital tradition.

The day before I wrote this column, President Trump posted the following tweet, in response to a federal judge in Seattle granting a TRO prohibiting enforcement of his Executive Order banning entry into the United States of persons coming from seven countries where Islam is the predominant religion: "What is our country coming to when a Judge can halt a travel ban which could prevent very bad people from coming into the country?"

What an easy question to answer. Every member of this Association knows the answer to that question. Every attorney licensed to practice law in Virginia knows the answer to that question. Every law student in the Commonwealth knows the answer to that question. And wouldn't it be great if every citizen in the country knew the answer to that question.

The answer is that we are a country governed by the Rule of Law. And in such a country, a Judge gets to make the determination that an executive order is contrary to the

law or the Constitution.

Now, it's not the purpose of this column to address policy considerations about this particular Executive Order, or whether that Judge might have, or should have, his decision overturned on appeal. But it is rightly the duty of all lawyers to explain to the citizenry that we live in a country where a judge *does* have the power to tell a President that what he is doing is illegal. Again, this column isn't addressing whether the Judge was correct or incorrect; that issue will be sorted out on appeal.

Wouldn't you rather the President had simply said, "We disagree with the Judge's ruling and will file an appeal" rather than complain about the foundation of our government and legal system?

Making remarks that question the Rule of Law are dangerous generally, and much more so when the person making those remarks is the President. So what should we as lawyers do about it?

First, it is becoming clear that lawyers need to be on the lookout not only for violations of the law by the federal government but more importantly for public statements that have the effect of questioning the Rule of Law.

Second, we as lawyers need to think about whether the public needs a crash course about the foundation of our American constitutional government. Do citizens who aren't well versed in the Rule of Law think President Trump's tweet is acceptable?

If that's the case, then third, should we as lawyers consider beginning a project to educate our community about the Rule of Law, and how it should always be preserved and protected, without regard to policies about which people could reasonably have different views?

Think about it. And know that the Foundation Board is always willing to consider supporting projects that will educate the community about the importance of the Rule of Law.
