With their legal and civic backgrounds, Mr. and Mrs. Squires have a keen interest in promoting civil justice for the indigent and disadvantaged, and hope their offer to match contributions will boost giving and help fill the void caused by the reduced levels of public funding.

When asked to comment on this offer, Gary Bryant, Chairman of the Pro Bono Committee of the NPBA, said: "Attorneys have a professional responsibility to assist the indigent in accessing legal services. While we are working to increase the level of pro bono services provided by attorneys in the area, we recognize that it isn't always feasible for attorneys to devote their time. For those attorneys who cannot perform pro bono services, making a contribution to the Legal Aid Society of Eastern Virginia is an excellent way to satisfy your professional responsibility, and this is a great opportunity to leverage your contribution to make twice the difference."




