

Duties:


- Assists customers in selecting and locating relevant research materials.

- Effectively communicates library policies and procedures to the public.
- Other duties as assigned by the Law Librarian and the Norfolk Law Library Board of Directors.

Preferred Skills, Abilities and Experience:

- Ability to communicate clearly and concisely in a friendly and positive manner with staff and library customers from diverse ethnic, socioeconomic, and cultural backgrounds, including Judges and attorneys and their staffs.
- Community engagement and service experience.
- Comfort with working independently in a team-oriented environment within established policies and procedures.
- Knowledge of and experience with library systems and technology.
- Experience using legal research databases such as Westlaw and Lexis Advance.

Each year an all-star cast of scholars, Supreme Court advocates, journalists and federal judges convene in Williamsburg, Virginia, for the Supreme Court Preview. The goal of the conference is two-fold: to get the audience up to speed on the specific cases the U.S. Supreme Court will decide, and to discuss and analyze persistent themes and challenges facing the Court today.

This year on October 6-7 there will be no shortage of hard questions to tackle: How far will the Court go in limiting the authority of administrative agencies? What does the commitment to free speech look like in the digital age? How will the Court refine its Second Amendment doctrine? And in light of heightened criticism facing the Justices, which cases will present moments for incrementalism, and where will the Court flex its muscles?
