2021 SCHOLARSHIP APPLICATION

Applicants must be 2021 graduating high school seniors (or the equivalent for home schooled students) and reside in one of the following cities: Norfolk, Portsmouth, Suffolk, Virginia Beach, or Chesapeake. Family members of the Board of Directors of the Norfolk and Portsmouth Bar Association Foundation and family members of the panel of judges for this competition are NOT eligible to participate.

Applications must be complete and must be RECEIVED no later than 5:00 p.m. on Wednesday, March 31, 2021. Prizes will be awarded in May 2021 at the annual meeting of the NPBA. Applications that do not include all required attachments (please see the list of items set out below) or that are late will not be considered. There will be no exceptions. PLEASE READ CAREFULLY and FOLLOW ALL INSTRUCTIONS.

Please mail (WARNING: If using the United States Postal Service to send your application materials, please be aware that there have been substantial delivery delays this year and plan accordingly to ensure that your application and all related materials are RECEIVED by the deadline of March 31, 2021) or deliver all **five (5) copies** (one original plus four photocopies of the originals are acceptable) **of each** of the following: your (1) application, (2) essay, (3) transcript, (if it comes in a sealed envelope, you may open the sealed envelope to copy) (4) letter of recommendation, and (5) any information, such as a FAFSA form, to support your claim of financial need. If you prefer, your completed application, essay, transcript, letter of recommendation, and FAFSA form may be scanned and emailed to: rhpowell@kaufcan.com. If the required materials are emailed, only the original needs to be scanned and sent.

Unless all required documents are emailed, you must submit five (5) copies or sets of each of the following five (5) items (Why 5 copies? – One for each of 3 judges, one for the Chairman of the Scholarship Committee, and one for the NPBA offices):

- (1) Your completed essay of approximately 500-750 words not including title, footnotes, or bibliography;
- (2) Your completed and signed Scholarship Application;
- (3) A letter of recommendation from a teacher or guidance counselor at your school;
- (4) A copy of your most recent school transcript; and
- (5) Any information you choose to submit that would support your claim, if any, of your financial need. You may use the FAFSA form that can be found at <http://www.fafsa.ed.gov> or the application for financial assistance you might have submitted with your college application.
